- Zach will investigate solar companies being present at Farmers Market
- REIV2G: Company that looks at cars in a fleet and indicates what current benefits are and when need to replace cars and what cars (EV) to use to replace.

New Business:

- Battery collection: Home Depot only collects large batteries. Rose mentioned people stop by office and ask about where to recycle batteries (i.e., C, D, AA, AAA, etc.).
- Farmers Market will have rotating tables for Community Boards
- Upper Merion 2025 and 2040—defer to June 2023 meeting.
- Zach will investigate PAR Recycle Works to get drop off at UM Township building.
- Farmers Market will be located at Norview Farms starting May 13th, 2023.
