AN ORDINANCE OF UPPER MERION TOWNSHIP ESTABLISHING A TOWNSHIP REAL PROPERTY TAX REBATE FOR ACTIVE UPPER MERION TOWNSHIP VOLUNTEER FIRE COMPANY VOLUNTEERS AND ESTABLISHING DEFINITIONS, REBATE CRITERIA, ADMINISTRATIVE PROCEDURES, AND AN APPEALS PROCESS

Section 1. Amends Chapter 149, Taxation, to provide for a new Article XI entitled “Active Volunteer Firefighter Real Property Tax Rebate” to provide as follows:

Article XI Active Volunteer Firefighter Real Property Tax Rebate

Section 149-80. Scope and Purpose. Establishes the scope and purpose of the ordinance to establish the rebate incentive for volunteers of fire companies.

Section 149-81. Definitions. Establishes definitions for terms used in the ordinance.

Section 149-82. Active Volunteer Service Tax Rebate Program. Establishes the criteria, eligibility, application, recordkeeping, review, injury and military service provisions.

Section 149-83. Township Real Property Rebate. Establishes the amount, limit and payment of the rebate.

Section 149-84. Procedures. Establishes the procedure for rebate implementation.

Section 149-85. Appeals. Establishes an administrative appeals process.
Section 149-86. Audit. Provides for a Program audit procedure by the
Township

Section 2. Provides for a severability provision
Section 3. Provides for a repealer clause
Section 4. Provides for an effective date of ordinance.
Section 5. Provides for an Failure to Enforce provision
